Note: this protocol is subject to change, without notice. last updated - 6 May2021

Precautions must be taken to reduce the risk of transmission of COVID-19 at CEP Championships and Events. One element of this is to check whether participants have any of the main COVID-19 symptoms. Each day that participants attend a CEP Championship or Event, prior to entering the venue, each participant shall have their temperature checked using an infra-red thermometer, and shall be asked questions relating to symptoms of, and exposure to, COVID-19.

No participant who has a measured temperature of 38°C or above, or who declares symptoms of, or exposure to, COVID-19 will be permitted on-site. A decision to deny access for these reasons is final and cannot be appealed.

In the event that a participant is denied access to the site due to failure of the self-declaration and/or temperature screening, their personal details will be provided to local health authorities (as required) and the CEP for the purposes of contact tracing. Have read and understood the Confédération Européenne de Pétanque (CEP) Return to Championship Protocols

Have read the CEP's Privacy Notice in response to COVID-19 which is always available in its most up-to-date form on the CEP's website.

Will comply with the relevant requirements in the CEP's Return to Championship Protocols in full;

Am satisfied that the CEP Return to Competition Protocols provide an adequate level of protection against the risk of transmission of COVID-19;

Acknowledge and voluntarily assume responsibility for any risk arising from my participation in all CEP Championships in which I participate;

Will notify the Championship COVID-19 Officer and CEP (at covid19@cep-petanque.com) that I have a confirmed case of COVID-19 OR if I experience any COVID-19 symptoms during the championship AND in the 14 days following my final departure from a championship;

Will, throughout the course of a Championship, compile an accurate list of and upon request identify to the COVID-19 Officer those persons with whom I come into close contact at that Championship (defined as: anyone with the following exposure to a confirmed COVID-19 case, from 2 days before to 14 days after the

confirmed case's onset of illness (defined as the date of the positive test): being face-to-face within 1 metre for a total of at least 15 minutes; direct physical contact. For the avoidance of doubt, anyone living in or sharing the same household or household-like setting (e.g. hotel room, apartment or hostel) is automatically classed as a Close Contact)

Understand that by participating in the Championship, I agree to be subject to the CEP's jurisdiction and that any failure to comply with the Return to Championship Protocols or the above stated declarations may constitute a violation of the CEP's Code of Conduct applicable to the Championship and may result in sanctions being imposed on me.
